By promoting and preserving the civil liberties of all people, we reaffirm that our nation was founded on the principle that our diversity is a profound strength, not a weakness.

Thus, I applaud CAIR for serving the people of Michigan since 1999. CAIR's work to uphold and defend the rights of American Muslims, and many others, has played an instrumental role in moving America forward. Our democracy requires the active participation of informed citizens and I applaud CAIR for empowering our citizens and giving them an authentic voice in the public square.

Finally, as you come together to reflect on the last 24 years of meaningful work, it is my sincere wish that you know your faith and continued service in communities like my own is an example to Americans everywhere. I trust that you will continue your work knowing it will result in a stronger America for all people.
